SYLLABUS OF COMPULSORY TRAINING COURSE FOR EXCISE & NARCOTICS PERSONNEL :

All excise & Narcotics personnel from the rank of Constable to Inspector shall undergo Compulsory Basic Training Course for a period prescribed by the Training Institution and the training shall consist of the following :

- (a) Drill with and without arms
- (b) Basic knowledge of Departmental Laws
- (c) Basic knowledge of Excise & Narcotics Manual
- (d) Basic knowledge of General Laws
- (e) Basic knowledge of CCS (Conduct) Rules, 1964
- (f) Basic knowledge of CCS (CCA) Rules, 1965
- (g) Basic knowledge of CCS (Leave) Rules, 1972
- (h) Basic introduction to relevant Laws & Rules
- (i) Collection of evidence, prosecution of cases etc.
- (j) Collection of Excise Duty and other related matters
